I am pleased to announce that every executive position was filled, and we have several new executive members. Your council for 2011-2012 is as follows:

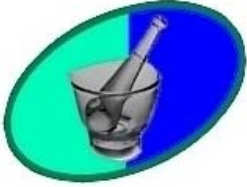
